NOTIFICATION

Pursuance to the decision of the Council in its 193th Session of PM&DC held on 25th March, 2019 regarding Senior Registrar which is reproduced below;

"It was agreed that a review of regulations regarding selection and promotion of teaching faculty with reference to both academic and research is required to be undertaken and that the regulations viz. a viz. the position of Senior Registrar shall be reviewed by the Law Committee by taking into account the ground realities in all provinces however till such review the position of Senior Registrar may be entertained by making necessary amendment in the relevant regulations. The regulations may be suitably amended to allow the institutions to frame their structure. The other issues were referred to Law and Regulatory Committee to submit report."

Later on, the case was again placed before the 194th Session of Council held on 20th April, 2019 at PM&DC Office, Islamabad regarding Status of Senior Registrars for teaching experience under PM&DC Teaching Regulations 2018 which is reproduced below;

"The Council felt that the Senior Registrars in various clinical specialties not only do clinical procedures but are also actively engaged in undergraduate and postgraduate teaching. After detailed discussion it was decided that the Senior Registrars be recognized as teaching trainees / trainers and be given due 50% credit of teaching experience, as was the practice in the past. It is antithetical to exclude those from teaching cadre, who are actively involved in teaching and clinical work in public Institutions. Also, the post of Senior Registrar will be added in the regulations along with the post of Specialist Registrar being used currently for the same defined post. The Council accorded approval to amend the regulations accordingly. The Law, Regulatory and Compliance Committee shall review these amendments."

In the light of above decision of the Council, the post of Senior Registrar is re-instated / continued for appointment / promotion accordingly.

This is being issued in compliance of decision of Council.
